

Tuition Schedule and Payment Policy 2023-2024 KEEP FOR YOUR RECORDS

3&4 Year-Old Preschool:

□ 2 days/week: Tuesday & Thursday AM - \$1,090/year

4&5 year-old Pre-Kinderga	rten

- 3 days/week: Monday/Wednesday/Friday AM \$1360/year
 2 days/week: Monday & Wednesday FULL DAY \$2125/year
 1 day/week: Friday HALF DAY \$513/year as an addition to another full day class
 1 day/week: Friday HALF DAY \$613/year as a standalone class option
- 1. A tuition deposit of \$100.00 is non-refundable once admission has been confirmed. The \$100.00 deposit is returned if application for admission is not confirmed.
- 2. The remaining tuition is due in full on or before September 1st or in monthly payments as specified below.

3&4 Year-Old Preschool:

<u>2 days/week: Tuesday & Thursday AM</u> - \$110/month and payable on the first day of each month beginning September 1st and continuing through May 1st.

4&5 year-old Pre-Kindergarten:

- 3 days/week: Monday/Wednesday/Friday AM \$140/month and payable on the first day of each month beginning September 1st and continuing through May 1st.
- <u>2 days/week: Monday & Wednesday FULL DAY</u>- \$225/month and payable on the first day of each month beginning September 1st and continuing through May 1st.
- <u>1 day/week: Friday HALF DAY as an addition to another full day class</u>- \$57/month and payable on the first day of each month beginning September 1st and continuing through May 1st.
- <u>1 day/week: Friday HALF DAY as standalone class option</u>- \$57/month and payable on the first day of each month beginning September 1st and continuing through May 1st.
- 3. If payment is not received by the 5^{th} day of the month, a \$20.00 late fee may be assessed and a reminder statement will be sent.
- 4. If an account is 30 days delinquent, the school board will do one or more of the following:
 - a. contact the family for payment:
 - b. request the family make a written appeal for tuition assistance and/or payment to their home church congregation;
 - c. request the family apply for tuition assistance (if funds are available).

- 5. If an account is 60 days delinquent, the school board will withdraw the child(ren) from school and advise the family to find an alternative means of education for their child(ren).
- 6. A \$30.00 fee will be assessed for returned (non-sufficient funds) checks.
- 7. Absence from school does not affect the amount of tuition due or the date the tuition is due.
